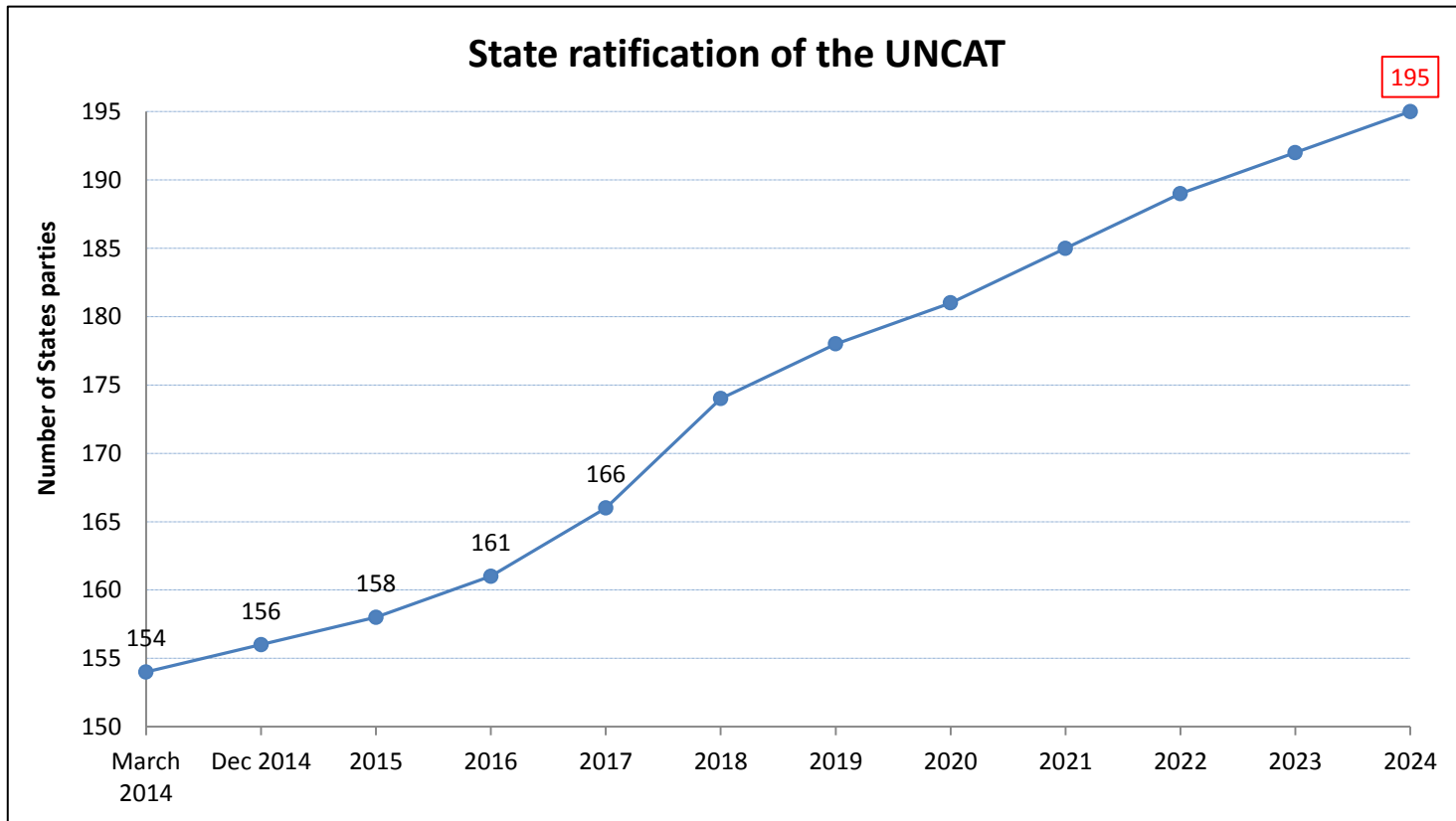


A. ACHIEVING UNIVERSAL RATIFICATION

2016 \Rightarrow 3 \Rightarrow 1 ratifications


2017 \Rightarrow 5 ratifications

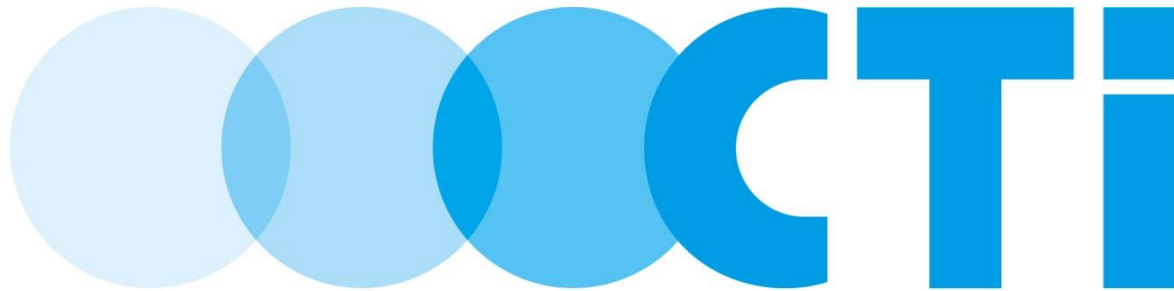
